**Stock Ownership Details**

**Cost of Share: \$1000.00**

- One share per family
- Share cannot be transferred or sold. Must be redeemed back to the Cadillac Country Club.
- Upon resignation from the Club, share will be redeemed at full purchase price, subject to the following conditions:

*Following the fifth continuous year of membership, a stockholder shall be deemed a fully vested stockholder and therefore eligible to redeem their share of stock. Shares will be redeemed in the order in which they are presented to the Club office; maximum of ten (10) per year. Additional shares may be redeemed subject to Board approval.*

**Value of Purchasing Stock**

1. Opportunity to voice concerns with voting rights
2. Lower dues than non-stockholders
3. Two eighteen-hole golf passes per shareholder for guest use
